- To apply for an AJS Trial Park key for Practice, you **must** have a current MWA Practice Supervisor Level 1 licence (PS1), **or** hold a current Coach, Clerk of Course or Steward licence with Level 1, 2, 3 or 4 accreditation(s). Riders can only ride when a Practice Supervisor or an Official (as above) is signed on. The online course to become a Practice Supervisor is from this link: [MWA On-line Courses](#)

KEY HOLDER RULES

- You must be a full financial member of the Club.
- You must have a current MWA competition or recreational licence and/or
- You must hold a current MWA Practice Official licence (Level 1 or above) or an MWA approved equivalent.
- Club membership details & your MA Riding or Official licence must be carried at all times, e.g. the MA App
- You should re-lock the gate upon entry and departure. If you leave the gate open and a non-member enters the Trials Park you could be fully liable if an incident occurs.
- Fully approved clothing and protective clothing is to be worn at all times whilst riding/practicing.
- TO PRACTICE AT THE PARK, THERE NEEDS TO BE AN MWA PRACTICE SUPERVISOR OR ANOTHER APPROPRIATE OFFICIAL SIGNED ON. **A PRACTICE SUPERVISOR OR OFFICIAL CANNOT RIDE AT A PRACTICE UNLESS THEY HAVE SIGNED ON AS A RIDER AND THERE IS ANOTHER OFFICIAL SIGNED ON TO TAKE OVER THE ROLE. BOTH PRACTICE SUPERVISORS AND OFFICIALS AND RIDERS MUST SIGN ON.**
- Motorcycling WA recommends all motorcycle activity should have some form of first aid and it is at the discretion of the club and practice supervisor to make sure there are adequate facilities/personnel in case of an emergency. Please be familiar with the Emergency Management Plan at the Trial Park.

UPON ACCEPTANCE AS A KEY HOLDER, I AGREE THAT:

- I will obey all Club, MWA and MA rules and regulations; and
- By using the facilities for participation in motorcycle riding, I am accepting all risks, dangers and obligations at my own risk and responsibility; and that
- Key usage is strictly for the member who has been issued their key. It is not to be handed to any other person for entry to the AJS Trial Park, whether they are an AJS MotoTrials member or not. Abuse of this rule will result in entry to the Trials Park being withdrawn.
