## **ACKNOWLEDGEMENT OF RISKS, DANGERS AND OBLIGATIONS**

WARNING: THIS IS AN IMPORTANT LEGAL DOCUMENT WHICH AFFECTS YOUR LEGAL RIGHTS AND OBLIGATIONS. READ IT CAREFULLY AND DO NOT COMPLETE YOUR MEMBERSHP APPLICATION UNLESS YOU ARE SATISFIED YOU UNDERSTAND IT.

I ACKNOWLEDGE that motorcycle sport is dangerous and that by engaging in the riding of motorcycles as part of the AJS MotoTrials Club of WA Inc. or by attending the Trial Park or events of the AJS MotoTrials Club of WA Inc. I am exposed to certain risks and dangers and am under certain obligations which risks and dangers and obligations I accept and participate in at my own risk. The risks, dangers and obligations include but are not limited to:

- (a) I may be injured, physically or mentally and may be killed;
- **(b)** That my property and machinery or equipment may be lost damaged or destroyed;
- (c) That other riders may ride dangerously or with a lack of skill;
- (d) That the conditions may be hazardous and may vary without warning or predictability;
- (e) That there may be no or inadequate facilities for treatment and transport of me if I am injured;
- (f) That any policy of insurance of or in respect of my life, physical or mental health may be voided.

CONTRACT EXCLUDING LIABILITY in consideration of the acceptance of me as a member of the AJS MotoTrials Club of WA Inc. I agree to absolute and release from all liability the AJS MotoTrials Club of WA Inc., its members, servants or agents and the authorities which own, occupy or manage the land on which motorcycle riding is to take place for any injury or damage to myself or my property arising out of participation in, or as observer to, motorcycle riding due to any negligent act, breach of duty, default and / or omission on behalf of the AJS MotoTrials Club of WA Inc., their members, servants or agents or on any part of any other persons or authorities who own, occupy or manage the land on which the motorcycle riding is to take place. I further acknowledge:

- (a) That I accept the property as it stands with all or any defects hidden or exposed;
- **(b)** That I will ride in a manner which is safe and with all due care and attention;
- (c) That I am a member of and attend the AJS MotoTrials Club of WA Inc. at my sole risk and responsibility.
